Low or No Emissions/Buses and Bus Facilities

NOFO released March 4 - \$1.5 billion in funding for zero emission programs

5339(c) Low No - \$1.1 billion

5339(b) Bus and Bus Facilities \$372 million

Applications are due by May 31, 2022

Applications for ZEV for both the Low No and Bus and Bus Facilities programs must include a Zero-Emission Transition Plan
